Complete this form to if you want to have automatic insurance cover in your super before you reach age 25 and your super account balance reaches \$6,000.

How do I apply?

- Carefully read and complete this form.
- If you'd prefer to do this online, visit plum.com.au/choosecover and log in to the secure member area, using your member number and password.

Your options

Please carefully read the below options:

- Choose the **'Yes, I want automatic insurance cover'** option, if you want to start your automatic insurance cover before you turn 25 and your super account balance reaches \$6,000.

By choosing to start your automatic cover, you are also electing to have any existing or future insurance cover maintained, even if your super account doesn't receive an amount such as a contribution or rollover for a continuous period of 16 months. We'll confirm that your insurance cover has started, the type and amount.

- Choose the **'No, I don't want automatic insurance cover in the future'** option, if you don't want your insurance cover to start automatically when you're at least age 25 and your super account balance has reached \$6,000.

When you join your employer plan, if you meet eligibility criteria, insurance cover may be available to you without the need for an application or health checks. This is called **"automatic insurance cover"**.

If you don't complete this form, you'll receive automatic insurance cover when:

- you reach age 25 and your super account balance reaches \$6,000, and
- you meet the eligibility criteria.

You'll find more information about the eligibility requirements, including whether pre-existing conditions are covered, in the relevant *Insurance Guide* which forms part of the *Product Disclosure Statement (PDS)*.

How do I make sure I have the right amount of insurance cover?

You should consider speaking to a financial adviser to find out the right amount of insurance cover for you. If you don't have a financial adviser, contact us on **1300 55 7586** and we can put you in touch with one.
